Context

The BCS Academy of Computing is a partnership between the BCS, the Council of Professors and Heads of Computing (CPHC) and the UK Computing Research Committee (UKCRC) and reports to the Institute's Trustee Board.

Early Career Advocate role

Early Careers Advocates (ECAs) represent young professionals working in academia or those in the first stages of an IT career (first 5 years of career), to help the BCS Academy of Computing Board in providing a voice for early career researchers, teachers/lecturers or industrialists in shaping the work of the Board.

Commitment

We expect that the role holder will endeavour to attend the four meetings of the BCS Academy of Computing Board held throughout the year, usually three meetings held online and one meeting at the BCS London offices.

In addition to this we expect that the holder to be responsible for the completion of tasks that fall within the key responsibilities laid out above

The appointment is for three years.
